- 2. The remote e-voting period commenced on Tuesday, November 12, 2024 (09:00 a.m. IST) and ended on Wednesday, December 11, 2024 (05:00 p.m. IST).
- 3. The remote e-voting facility was provided by Link Intime India Private Limited ("LIIPL").
- 4. The Notice of Postal Ballot was sent in electronic form only to all the shareholders whose names appear in the Register of Members / List of Beneficial Owners as received from Depositories i.e National Securities Depository Limited ("NSDL") and Central Depository Services (India) Limited ('CDSL') and whose e-mail addresses are registered with the Company/LIIPL /Depository.
- 5. The hard copies of the Notice along with Postal Ballot forms and pre-paid business envelope were not sent to the Members for the Postal Ballot in accordance with the requirements specified under the MCA Circulars.
