Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") read with Para A of Part A of Schedule III of the Listing Regulations and in compliance with SEBI (Share Based Employee Benefits and Sweat Equity) Regulations, 2021 ("SBEB Regulations"), please be informed that the Nomination and Remuneration Committee of the Board of Directors of the Company, by way of circular resolution passed today, i.e., on June 16, 2025, has approved the allotment of 15,000 fully paid up equity shares of face value of INR 2/- (Indian Rupees Two only) per share to the employees of the Company pursuant to exercise of options granted to them under the "**MIL ESOP 2021**".
